

ABOUT THE DIVISION

Rehabilitation psychology is the study and practice of the application of psychosocial principles to individuals with an array of emotional, physical, and cognitive disabilities.

Established in 1958, APA Division 22 is the primary professional organization serving rehabilitation psychologists who are concerned with the social and personal growth of individuals with disabilities from a perspective that emphasizes the whole person.

Rehabilitation psychology entails clinical practice, development and administration of programs, research, teaching, public education, injury prevention and health promotion, health policy, and advocacy for persons with disabilities and chronic health conditions.



MEMBERSHIP BENEFITS

Members of APA Division 22 enjoy a wide range of benefits, including but not limited to:
